IJAMBO RY'IBANZE

Urwego rw'Ubucamanza rwihaye intego yo gutanga ubutabera bunoze kandi bwihuse. Ni muri urwo rwego, Urukiko rw'Ikirenga rwiyemeje kubaka ubutabera bushingiye ku mirongo yatanzwe (*precedent/jurisprudence*) hagamijwe gufata abantu kimwe ku buryo abahuje ibibazo babona ibisubizo bisa, no kwirinda imanza zitari ngombwa mu nkiko. Kugira ngo ibyo bigerweho, hafashwe ingamba ko imirongo yafashwe mu manza Urukiko rw'Ikirenga ruca, izajya ihurizwa hamwe ikamenyeshwa abo bireba bose, nibura rimwe mu gihembwe. Ni muri urwo rwego Urukiko rw'Ikirenga runejewe no kongera kubagezaho imirongo yatanzwe mu manza zaciwe kuva mu kwezi k'Ukwakira 2024 kugera muri Mutarama 2025.

Abacamanza, abashakashatsi mu nkiko, ababuranyi (Abavoka n'Abashinjacyaha cyane cyane), basabwe kujya bayitaho kugira ngo twese hamwe dufatanye guteza imbere no gushimangira uyu mucu wo gutanga ibisubizo bimwe ku bibazo bimeze kimwe.

Turasaba Abacamanza kwita kuri iyi mirongo mu manza baca tunabibutsa ko batemerewe kunyuranya na yo kimwe n'indi mirongo yatanzwe n'izindi nkiko uko zigenda zisumbana nk'uko biteganywa mu mabwiriza ya Perezida w'Urukiko rw'Ikirenga yo ku wa 15/03/2021 agenga itangazwa ry'ibyemezo by'inkiko.

Abavoka kimwe n'undi wese ubifitemo inyungu, barashishikarizwa kubaha imirongo yatanzwe, ntibakomeze gutanga ibirego bitari ngombwa kandi bazi ibisubizo inkiko zatanze ku birego bimeze nka byo. Igihe kandi hari umurongo batemeranya na wo cyangwa bumva utanoze, bakwibuka ko itegeko ryateganyije uko bene iyo mirongo iregerwa ikaba yakosorwa cyangwa igahindurwa (reba ingingo ya 65 na 73 y'itegeko rigena ububasha bw'inkiko). Mu gihe ariko umurongo utarahinduka, ugomba kubahirizwa na bose uko uri.

Nyuma y'urupfu rwe, umutungo we wasigaye ucunzwe n'umuhungu we witwa Ntirivamunda Alphonse kuko ari we wari warahawe ubwo bubasha, nyuma ajya gutura mu mahanga, maze imitungo yacungaga ikomeza gucungwa na Nyiranganizi Félicité, umugore muto wa Munyampeta Gaspard.

Mu rubanza rubanziriza urundi rwaciwe ku wa 05/07/2024, uru Rukiko rwemeje ko Nyiramugwera Zilipa agomba gufatwa nk'umugore wemewe n'amategeko wa Munyampeta Gaspard, akaba afite uburenganzira ku mitungo yasizwe n'umugabo we, ruvuga ko uru

Urukiko rwasanze nta kigaragaza ko inkongi y'umuriro yakomotse ku nsinga za EUCL Ltd nk'uko byemejwe n'inkiko zabanje kubera ko ibimenyetso byatanzwe bihuriza ku kuba iyo nkongi yaba yaratewe no gukoranaho kw'insinga (court circuit) kandi ko izo nsinga zitari zifunitse. Bikaba byumvikana ko kuba insinga z'amashanyarazi zarakoranyeho bigatuma habaho inkongi bidahagije ngo hemezwe ko izo nsinga zari iza EUCL Ltd, nk'uko byashimangiwe n'ibyasobanuwe muri raporo y'impuguke yashyizweho na MUA (Electrical Engineer's Report) ko igihe cyose inzu ihuye n'ikibazo cy'inkongi y'umuriro, abantu bahita bavuga ko yatewe n'umuriro w'amashanyarazi (énergie électrique) nyamara atari byo kuko iyo nkongi ishobora guterwa n'izindi mpamvu. Bikumvikana ko Urukiko Rukuru rutagombaga gutegeka MUA nk'umwishingizi wa EUCL Ltd kwishyura amafaranga SANLAM A.G Plc yahaye Quincaillerie Cleal.

Urukiko rwabanje gusuzuma ibijyanye no kumenya agaciro ka sheki igihe yatanzwe ariko ntiyishyure umwenda ugomba kwishyurwa, maze rusanga igihe KCF Ltd yatangaga sheki ziburanwa nta mafaranga yari ifite kuri konti, bityo hakaba hari hakiriho umwenda wose; ruvuga ko KCF Ltd igomba kwishyura CIMERWA Ltd 90,350,000 Frw y'umwenda iyibereyemo ndetse na 72,321,912 Frw y'inyungu ziwukomokaho zibazwe mu buryo bukurikira:

Ku kibazo kijyanye no kumenya niba Karangwa Raymond yategekwa gufatanya na KCF Ltd kwishyura umwenda uregerwa, Urukiko rwasanze atagomba gutegekwa gufatanya na KCF Ltd kwishyura uwo mwenda kuko CIMERWA Ltd itanga ikirego itagaragaje niba Karangwa Raymond (i) yarakoresheje nabi imiterere ya sosiyete agamije uburiganya; (ii) yarishe amategeko (iii) cyangwa ngo abe yarafashe nabi umutungo wa sosiyete nk'aho ari umutungo we ku giti cye ku buryo byaba byaratumye habura ubwishyu.
